

THE IMPORTANCE OF THE OFFICE OF A PUBLIC ADMINISTRATOR

As a public administrator, you can work as a government policy analyst, public relations manager or regional planner.

For its part, the United Nations would assist governments in creating and strengthening national capacities in fiscal policy analysis and economic management, and in promoting a proper environment for capital flows for investment, private sector development, transparency and accountability. What is important are the results of its activities or non-activities. Economic aspects cannot be the only guide and, moreover, it has been proved on many occasions abroad that the exclusion of public tasks from the responsibilities of public authorities did not bring expected savings, however, it resulted in the erosion of the values and principles upon which the provision of public services was based. Minimum political accountability, in comparison with Western democracies, is drawn even in such cases. Orientation not only in the legislation but also in the organization of administrative authorities and even inside the individual authorities is often difficult for citizens, despite numerous improvements introduced in recent years. The average time needed for the complete setting-up of a firm is almost four months and sometimes it takes up to two years. With respect to capacity-building, the Assembly will discuss improving civil service systems, organizational strengthening, the enhancement of policy-development capacity, strengthening financial management for development, human resource development for the public sector and the development of administrative capacities for post-conflict and crisis conditions. The orientation of public administration towards securing public interests can be understood as its direction towards the solution of concrete problems of individual citizens and population groups and towards securing the functioning of the society as a whole. The current role and functions adopted by public administration owes its origin to the changes which the human history has witnessed in the last couple of centuries. Human resource management is an in-house structure that ensures that public service staffing is done in an unbiased, ethical and values-based manner. The increase in the number of functions undertaken by the government require highly specialized, professional and technical, services. Leaders should invest in people, upgrading the capacity of national training institutions to develop a core group of professional trainers, the report states. According to the survey, more than one half of citizens are not ready to get personally involved in solving public issues. This comprises tasks in the sphere of security and internal order, regulation and enforcement of the fulfilling of legal duties, the application of administrative supervision tools, the imposition and execution of sanctions within the limits of administrative authority etc. Likewise, the United Nations programme in public administration and finance should be renamed the United Nations programme in public administration and development. Public budgeting is the activity within a government that seeks to allocate scarce resources among unlimited demands. And the duty of enforcing the adoption of standards and enforcing this cooperation rests with management alone. To that end, the Secretary-General recommends the establishment of a trust fund for United Nations activities in public administration and development. What do Public Administrators do? The separation of politics and administration advocated by Wilson continues to play a significant role in public administration today.
